Puppy Contract

On this ___ day of ___, 20___, Low Country English Bulldogs, herein referred to as the Seller, and ___, herein referred to as the Purchaser, hereby agree to the sale/purchase of the puppy/dog known as ___, for \$___ under the following conditions:

B. Mutual Agreements by both parties:

- FIRST RIGHTS POLICY:** If for any reason the original Purchaser cannot keep the adopted puppy, they MUST return the puppy/dog to Low Country English Bulldogs. The Purchaser agrees NOT to resale any puppy/dog they purchase from the Seller. In most circumstances the Seller will pay the Purchaser the expense to have the puppy/dog returned to the Seller. The Purchase will receive an in-house credit for 50-100% of the purchase price according to the circumstances. The Purchaser or a family member may use the credit at any time for a like puppy. This will be determined by Low Country English Bulldogs on an individual basis. No credit will be applied if the puppy/dog is in poor health or condition from neglect.
- PAYMENT OF BALANCE:** Payments in any amount are accepted at any time after a deposit is made on a particular puppy. Full Payment must be made by 6 weeks of age or at time of adoption if puppy is past 6 weeks. Shipping will occur no sooner than 14 business days after full payment.
- AKC PAPERS GUARANTEE:** AKC Registration papers are guaranteed on all animals, whether Full or Limited, and registration numbers and codes will be provided to the Purchaser via e-mail for registration at AKC.org after the required wellness check results have been e-mailed to us. For puppies that are registered by Low Country English Bulldogs, the signed certificate will be mailed after the required wellness check results have been e-mailed to us.

4. SHIPPING POLICY: Shipping is the sole responsibility of the Purchaser. However, the Seller will assist the Purchaser on an individual basis.

5. REFUND/RETURN POLICY: No refunds under any circumstances. Any funds paid as a deposit, partial payments, or full payments made to owners or Low Country English Bulldogs, before or after delivery of animal are non-refundable. Funds not used on chosen animal for any reason will be placed as an in-house credit under the name of the purchaser to be used by said at a future date on a puppy of their choosing. Some transactions will incur expenses to the Seller that will be deducted from the credit to the purchaser, including but not limited to advertising to resell and care for puppy held for purchaser.

6. DEPOSIT POLICY: The Seller requires a minimum 20% of the purchase price deposit to secure any puppy. Deposits are NOT refundable. If you change your mind, decide that you do not want the puppy, or find out that you cannot have a puppy; you will forfeit your deposit. By placing a deposit, you agree and understand these terms. By placing a deposit on any puppy, you are making a legal agreement to purchase that puppy. (Deposits not used are issued as credit if needed for unusual circumstances)

C. Payment.

1. The Seller requires 20% of the entire adoption fee posted to hold your puppy/dog (with a minimum of \$300). The Purchaser has the option to pay \$300 via PayPal to make sure the puppy/dog is secured immediately. THE REMAINING 20% MUST BE PAID WITHIN 24 HOURS via one of the approved payment options.

Note: Balances are due by 6 weeks of age. If your puppy is over 6 weeks old, full payment is required immediately.

D. Other Considerations.

1. The Purchaser chooses the following method to settle any outstanding balances.

- CASH-to be paid in full at our office by 6 weeks of age or before.
- US Postal Money Order-to be sent Priority mail by age of 6 weeks.
- This puppy/dog is past 6 weeks old-I will pay my balance in full now.
- The balance is paid in full.
- Other Arrangements made and agreed upon with Low Country English Bulldogs as listed below.

2. Are you buying this puppy as a Pet only?

- YES: I agree this puppy is being sold with no breeding rights, and no AKC papers will be given until after the spay/neuter is verified by a Vet via microchip #.
- NO: I am buying this dog/puppy with Full AKC breeding rights; I understand and agree that Low Country English Bulldogs does not guarantee the breeding potential of this dog/puppy.

3. Bulldogs can be High Maintenance Animals. I understand that Low Country English Bulldogs DOES NOT pay for or reimburse for ANY and ALL Vet Bills the purchaser may incur in connection with said animal once the purchaser or shippers pick up the animal.

4. Confidentiality/Non-Disclosure Agreement: Low Country English Bulldogs reserves the right to complete privacy and confidentiality in any business transaction with any client. The Purchaser agrees to uphold that right and agrees not to discuss in ANY form or with any person, any detail of our business together from the start to finish, especially pertaining to claims and disputes. This means verbally, online, on Face Book, in chats, forums, groups, in email, in personal messages, text, etc. Low Country English Bulldogs agrees to be held to the same as stated so as to protect the Purchaser's privacy.

5. ARBRITRATION: All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration in the state of Georgia, the County of Wayne.

I have read the above stud contract and agree to all terms and conditions, and by my signature acknowledge having received a copy of the agreement.
