# **Stud Service Contract**

On this day of, 20, Low Country English Bulldogs, herein referred to as Stud Dog Owner, and
the owner of, AKC #, and, herein referred to as Bitch Owner, and the owner of, AKC #
, hereby agree to breed their respective dog and bitch, by method of artificial insemination, to
include the following terms:
A. Mutual Agreements by both parties:
A. Widdai Agreements by both parties.
1. Both parties agree that the Low Country name will not be used in the sale of the puppies. The
STUD DOG name can be used as the name of the sire only. The puppies produced by this are the
property of the Bitch Owner and are not puppies belonging to Low County English Bulldogs and will not
be sold as Low Country puppies with the exception of "Pick Puppy Back Agreements". Pick Puppy
Agreements will be noted in the "Other Considerations" portion of the contract. Therefore, in all
advertising or selling of these pups Bitch Owner will not use Low Country English Bulldogs as a selling
key.
2. Both parties agree that this stud service agreement is for stud service only, and is not to be
construed as a guarantee of live puppies upon whelping.
3. Both parties agree that two live puppies constitute a litter.
5. Both parties agree that two live pappies constitute a litter.
4. Both parties agree that their own dog involved in this breeding is in good health as evidenced by
an updated veterinary examination, including all current vaccinations.
5. Both parties agree that if the bitch fails to become pregnant, a return stud service for the Stud
Dog Owner will be given to the same bitch without an additional stud fee within one year of the first
mating.
6. Both parties agree that if the stud dog dies, a return stud service will be offered by a stud dog of

#### B. Agreement by Owner of the Stud Dog in the event of breeding by artificial insemination.

- 1. The Stud Dog Owner agrees that collection of sperm will be made on the dates provided by the Bitch Owner as dictated by progesterone testing.
- 2. The Stud Dog Owner agrees that the collection shipped must be considered viable for breeding by veterinary standards for artificial insemination. Collections will be shipped in special cold packed boxes.
- 3. The Stud Dog Owner agrees that shipment of the collection will take place on the dates requested, unless in the event of a natural disaster or national emergency resulting in the halt of veterinary services and/or transport carriers. Proper notice required please see C2 below.
- 4. The Stud Dog Owner agrees that collection of the semen may be performed by a veterinarian at the insistence of the Bitch Owner. The Bitch Owner shall agree to pay for all resulting fees from this collection.

## C. Agreement by the Owner of the Bitch in the event of breeding by artificial insemination.

- 1. The Bitch Owner agrees that any puppies resulting from this mating not being kept by the Bitch Owner will **NOT** be sold to puppy brokers or pet stores.
- 2. The Bitch Owner will provide the Stud Dog Owner with two dates for insemination based on progesterone testing done to predict ovulation by the veterinarian of the Bitch Owner. (In the event a 3rd shipment is needed, there will be an additional charge of \$100, shipping fees, and shipping box deposits.)
- 3. The Bitch Owner agrees to give the Owner of the Stud Dog forty-eight (48) hours notice prior to desire shipment date of collection. Shipments can only be made Monday through Friday and will be delivered by a shipper of the Stud Owner's choosing. The Bitch Owner is welcome to make a shipping preference known.
- 4. The Bitch Owner agrees that artificial inseminations will be performed by a veterinarian with prior artificial insemination experience.
- 5. The Bitch Owner agrees to pay all shipment fees and/or delivery charges to the Stud Dog Owner in addition to the stud fee.

- 6. The Bitch Owner also agrees to return shipping boxes via regular mail within 10 days. The Bitch Owner understands that a \$50 deposit per shipping box will be included in the shipping charges that will be reimbursed upon return of the shipping boxes.
- 7. The Bitch Owner agrees to pay for all veterinary and shipping fees associated with a return stud service, if one transpires.

(The Shipping Fee is dependent on the manner in which the Bitch Dog will be inseminated. An Artificial Insemination cost \$350 (for 2 shipments), Surgical Insemination and Trans-Cervical Inseminations cost \$200 (for 1 shipment).)

#### E. Other Considerations

- 1. Both parties agree that semen will be shipped by the Stud Owner on a first come, first served basis. Once signed contracts have been exchanged and the shipping fee has been paid, the Bitch Owner will become "locked in". They will receive preference over anyone completing contracts after that date.
- 2. Both parties agree that two puppies constitute a litter. In the event that only one puppy is whelped, the puppy will be sold by the Bitch Owner and the monies split evenly between the Bitch Owner and Stud Owner. In the event that the Bitch Owner chooses to keep said puppy, both the Stud Owner and Bitch Owner will decide a selling price and the Bitch Owner shall pay the Stud Owner half the selling price.
- 3. The Bitch Owner agrees that the litter will be verified with photos and records from your veterinarian directly to the Stud Owner within 24 hours of birth.
- 4. The Bitch Owner agrees to provide the Stud Owner weekly photos of ALL puppies and a complete physical veterinary checkup of the whole litter by 3-4 weeks of age. The Bitch Owner agrees that all records of the checkup will be provided directly from the veterinarian.
- 5. Both parties agree that the selection process will begin at 4 weeks of age. If the Stud Owners chosen puppy should become sick or die, the selection process will start over. The Stud Owners next selection will take priority over any other promised puppies.

- 6. The Stud Owner agrees to pay any delivery charges for the puppy. The Bitch Owner also agrees to provide the Stud Owner with all needed information to register the litter and any other necessary paperwork.
- 7. The Bitch Owner agrees that after the puppy has passed a veterinary check by the Stud Owner, the contract will be complete.
- 8. REFUND/RETURN POLICY: No refunds under any circumstances. Any funds paid as a deposit, partial payments, or full payments made to Low Country English Bulldogs, before or after delivery are non-refundable. Funds not used for any reason will be placed as an in-house credit under the name of the purchaser to be used by said at a future date of their choosing.
- 9. Confidentiality/Non-Disclosure Agreement: Low Country English Bulldogs reserves the right to complete privacy and confidentiality in any business transaction with any client. The Purchaser agrees to uphold that right and agrees not to discuss in ANY form or with any person, any detail of our business together from the start to finish, especially pertaining to claims and disputes. This means verbally, online, on Face Book, in chats, forums, groups, in email, in personal messages, text, etc. Low Country English Bulldogs agrees to be held to the same as stated so as to protect the Purchaser's privacy.
